Gibson asserts various claims for trademark infringement against Viacom and JHS, alleging that Flying V SpongeBob SquarePants ukuleles have been advertised and distributed without Gibson's authorization. On March 8, 2013, the court granted Viacom's motion to dismiss for failure to state a claim for relief against Viacom. (Dkt. No. 24.)
